

INFORMATION AND GENERAL CONDITIONS

1. Products

Stålprofil AB ("Stålprofil") develops and sells insulated and non-insulated profile systems (profiles, glazing beads, screws, rubber gaskets, etc) in steel and stainless steel (EN 1.4404 / AISI 316L) ("Profile Systems") to be used for manufacturing of glazed facades, walls, windows, doors and sliding door sections ("Sections"). The final manufactured Sections can be thermal insulating, fire-, bullet- and burglary resistant and are resistant against wear and tear. The Profile Systems are intended for interior and exterior Sections in, e.g., offices and business premises, schools, banks, shopping malls, airports, embassies, prisons, hotels, hospitals, service homes etc. The Profile Systems in stainless steel are in acid resistant quality.

2. Manufacture of sections

2.1 Manufacturing of the Sections must be made by specialist and experienced metal working companies for facade-, wall-, window-, door- and sliding door sections with adequate knowledge. The manufacturer must fulfil valid national and international standards and regulations, be under third party control as required as well as have experience with glass, hardware, installation, etc. of Sections.

3. Information and consultation

3.1 Information and documentation from Stålprofil is a free of charge service made to the best of Stålprofil's knowledge and ability and intended as suggestions and ideas for the customer. It does not form part of Stålprofil's quotation or the contract of sale and shall not represent a consulting contract. This means that Stålprofil shall not be liable for said service and the result thereof. The customer or its expert should always critically study the information and documentation and evaluate the suggestions and ideas to be suitable, appropriate and fit for the purpose. For example wind loads and other stresses may vary and are impossible to cover.



- 3.2 Stålprofil's free of charge technical consultation during planning and project preparation is exclusively relating to Stålprofil's Profile Systems and accessories. All ideas, suggestions for tender, design and installation, static calculations, material calculations, etc., provided within the context of consultation and discussion in the form of sketches, drawings, correspondence or plans etc. drawn up by Stålprofil are made to the best of Stålprofil's knowledge and ability. It is a free of charge service, which does not form part of Stålprofil's quotation or the contract of sale and shall not represent a consulting contract. This means that Stålprofil shall not be liable for said consultation and the results thereof. The results of the consultation provided by Stålprofil may not be used for any other purpose than for purchase of Stålprofil's Profile Systems.
- 3.3 The information and results of consultation provided by Stålprofil must also be checked and approved by the architect or the builder of the object in question prior to further use or further processing. In particular, the responsibility for planning on site rests with the builder and the architect. This means that the information on the situation on site from the customer and/or builder and/or the architect will not be confirmed or approved by Stålprofil and Stålprofil shall not be liable for said information.

4. Miscellaneous

- 4.1 Information and advice to the customer by Stålprofil of a binding nature requires a separate written agreement between the parties including remuneration to Stålprofil.
- 4.2 Installation and use of Stålprofil's software requires a written license agreement between the parties. See **End-user License Agreement** for Stålprofil's KBK.
- 4.3 Stålprofil reserves all rights in its catalogues, brochures, test documentation and other documentation, which may not be duplicated or distributed unless approved by Stålprofil. Stålprofil reserves the right to make revisions in the documentation as well as changes in the constructions of the Profile Systems and the accessories without prior notice.
- 4.4 In addition to the condition set forth in this **Information and General Conditions**, Stålprofil's **General Sales Conditions** shall apply to all sales by Stålprofil unless otherwise agreed in writing.
